Information Clause

According to Art. 13 of Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46 / CE, referred to as "GDPR", the Polish Sociological Association informs that:

1. The administrator of your personal data is the Polish Sociological Association.
2. Your personal data are processed to perform the statutory tasks of the Association.
3. The legal basis for the processing of your personal data is Article 6(1)(b) RODO, i.e., the performance of a contract or taking action prior to entering into such a contract. The adoption of Article 6(1)(b) RODO results from the fact that the Statute in the Polish law constitutes a specific type of agreement defining the rights and obligations of the members of the Association, and on its basis they are executed.

4. The Executive Board of the Polish Sociological Association receives your data from the branch/section to which you have applied for membership.
5. Your data may be entrusted to the sections and divisions of the Polish Sociological Association, the entity providing HR and accounting services, the entity providing IT services, the entity providing legal services, and the Association's partners.
6. Your personal data will be processed for the duration of membership and after its termination for the limitation period of claims arising from membership.
7. You are not obliged to provide your personal data; however, if you decide not to provide them, you will not be able to become a member of the Association.
8. You have the right to access, rectify, transfer, delete, or restrict the processing of your personal data, as well as to object to further processing thereof.
9. We do not process your data in a way that would lead to automated decision-making, including profiling.
10. Your data will not be transferred outside the European Economic Area or to an international organization.
11. You have the right to lodge a complaint with the supervisory authority: President of the Personal Data Protection Office, 2 Stawki Street, 00-193 Warsaw.
